Why make it more sustainable?

In order to prevent climate change, large companies, such as EMG Netherlands, must reduce CO2 emissions. To this end, the European Union has drawn up the Energy Efficiency Directive (EED) to reduce CO2 emissions within Europe by 40% by 2030 (compared to 1990). Companies are encouraged to reduce their energy consumption by means of an EED audit. The EED audit provides insight into the energy consumption of, for example, buildings, installations and processes within the company.

How does EMG Netherlands do that?

- EMG Netherlands opts for ISO 14001 certification in combination with SCCM's CO2 reduction. With this, EMG Netherlands automatically complies with the EED obligation.
- The EMG Netherlands environmental management system describes the controlled way in which environmental aspects, performance and effects are safeguarded within the organization. With the help of this system, EMG Netherlands involves more employees in making the organization more sustainable. The environmental coordinator coordinates, implements and maintains the system, supported by the board members. The environmental coordinator is responsible for monitoring the system in collaboration with other departments, an external consultancy and the management.
- With the slogan 'let's unite', EMG Netherlands enters into sustainable partnerships with stakeholders such as clients, suppliers, their neighbours, the municipality and the ultimate users.

Environmental goal of EMG Netherlands?

The aim of EMG Netherlands is to keep the environmental impact to a minimum and, where possible, to take measures to improve its environmental and energy performance. The main environmental aspects within EMG Netherlands are electricity- and fuel consumption. EMG Netherlands is in continuous development and continuously implements improvements to improve performance.

Concrete approach

The vehicle fleet is examined, as well as monitors, central heating and other assets. Small adjustments can already help a lot, such as printing less, double-sided printing, the mobility of employees and creating environmental awareness.

An annual management review evaluates the past period and determines whether and to what extent the objectives have been achieved. In addition, continuous research is being conducted into energy-efficient applications, which in turn will lead to new environmental objectives. Since creativity and innovation are of paramount importance within the organization, EMG Netherlands will also always try to improve in the field of the environment.
